General Conditions Paardenwagentje.nl

The horse trucks: It concerns vehicles light load up to 3.5 tons, which require a driving license B (BE-driving license required if trailer is involved). They can only be booked through the booking system on the website. Both rent and mileage allowance have been determined. The extra kilometres will be deducted from the deposit. The tenant signs the tenancy agreement and the general conditions at the start of the rental period and agrees with the general conditions mentioned on the website and in the agreement. Rent and deposit will be paid by banktransfer before departure and a copy of the driving license (front and back) will be handed.

- a If horse truck is not returned in time, tenant will receive a 250 EUR fine inclusive of 21% VAT. If possible, it will be deducted from the deposit.
- b Tenant will take good care of the vehicle. Damage, irrespective of its cause, must be fully compensated by the tenant, unless tenant can call in the insurance company or unless damage arises within the warranty period and manufacturer can repair it. Tenant will exclusively use the vehicle for its purpose, in other words for horse transport.
- c Tenant is responsible for the costs for fuel (diesel), washing, excessive wear and costs which result from negligence or improper. The horse truck must be cleaned (rinsed) before it is returned. The cabin's interior must be cleaned as well. If it turns out that the horse truck is not clean, it will be cleaned by us and cleaning costs, 100 Euro inclusive of 21% VAT, will be at tenant's expense. Dogs whom travel along in the cabin must be at the ground at all time. Dogs are not allowed on the bench and any hair that fall of the dog must be cleaned as well as the rest of the horse truck.
- d The horse truck is delivered with a full diesel tank and must be returned with a full fuel tank as well. If the vehicle is returned without a full fuel tank, costs for filling it will be at tenant's expense. In addition, Euro 10 administration costs is charged.
- e Tenant is responsible for the consequences of traffic offenses, fines or whatever incident which is contrary to the law of the country where the incident occurs. Tenant knows and respects the traffic regulations and the rules of the country in which tenant drives. Tenant enquires about obligations, traffic rules, prohibitions etc. Tenant is responsible for each violation which results into damage, offense, complaint, fees (even if letter receives it upon after termination of the tenancy agreement) which takes place during the term of the tenancy agreement.
- f At any time, letter is entitled to check the condition of the vehicle.
- g Tenant is not allowed to give other persons, who aren't authorized to drive a horse truck with driving license B, permission to use the horse truck. In addition, tenant is not allowed to rent the vehicle. The vehicle may only be driven by tenant or by a driver appointed by the tenant, whom the letter met when the horse truck was collected. In case of violations or accidents caused by another driver/tenant, damage might not be covered by the insurance company. Tenant always remains fully liable for all damage, fines and fees, and for administration costs as well.
- h The number of passenger (3 persons) and the max. load capacity has been determined by the car documents (s. glove compartment) of the vehicle and may never be exceeded. All damage and/or fines which result from violating this article will be at tenant's expense. Letter can't be held liable if the horse truck is overloaded.
- i Insurance is included in the rent; max. 1000 excess in case of damage. Damage to other persons or to the vehicle must immediately be reported (in writing) to the letter, who will inform the insurance company. Tenant will supply a clear accident report within 24 hours, if not tenant loses all rights to the concluded insurance and the costs and consequences will be fully at his expense. Deliberate omission of damage will be fined: Euro 50 plus damage compensation. Tenant must compensate all costs for repair as a consequence of the claim he/she is responsible for within 8 days upon receipt of the invoice.
- j If the horse truck breaks down and it is no longer possible to continue driving or if continuing driving is too difficult or dangerous, tenant will immediately contact letter. Letter is not liable for any damage as a consequence of this break down (for example not able to participate in a match, sales which is cancelled etc.). Tenant is not allowed to carry out repair himself, except if letter explicitly grants permission. Should tenant carry out repair or have the horse truck repaired without permission of the letter, tenant will be responsible for the costs. If the tenant is crossing the border to another country in Europe, the tenant is, in any case, responsible for returning the horsetruck to the location of return in the Netherlands. In cases of defect the cost for return are on behalf of the tenant.
- k Letter is allowed to terminate the tenancy agreement at all times if tenant doesn't meet his essential obligations, without prejudice to the right to compensation. Letter is entitled to claim 15% of the total amount. The costs to remove the vehicle will be at tenant's expense. The recovery costs of the vehicle are, in case of attachment, at tenant's expense. In case of attachment the tenant will immediately inform the letter.
- l Tenant is not allowed to add accessories to the vehicle, without explicit permission of the tenant.
- m Tenant is not allowed to provide the horse truck with advertisements.
- n Tenant is not allowed to paint the horse truck.
- o Interim termination of the tenancy agreement is not allowed.
- o The reservation can be cancelled under below conditions: If the reservation is changed or cancelled 7 days before start of the rental period at the latest, the cancellation costs will be 20% of the rent. If the reservation is cancelled within 7 days before start of the rental period, the cancellation costs will be 100% of (total rent inclusive of VAT). Cancellation by Rentmyhorsetruck.com in case of force majeure such as extreme weather conditions (black ice, snow, persistent rain) and technical defects to the horse truck. The total rent or the deposit will be fully (100%) refunded, within 24 hours.
- p It is not allowed to smoke in the horse truck. It will be considered as damage.
- q At the end of the rental period tenant will return the horse truck to the letter in a good condition, without any damage, with a full tank and inclusive of all required paper documents.
- r Letter can never be held liable for possible injuries or damage to passengers, the horse or his/her material before, during and after transport.
- s Dutch law is exclusively applicable to this agreement. Each dispute as a result of this agreement will be exclusively be submitted to the court of Breda (The Netherlands).
